IN PLEBISCITE VOTE IN NORTHERN MARIANAS ON COMMONWEALTH
COVENANT JUNE 17. OF THESE, 3945 VOTED IN FAVOR OF COVENANT
AND 1,060 VOTED AGAINST, THUS 78.8 PERCENT OF VALID BALLOT
FAVORS COVENANT. APPROXIMATELY 95 PERCENT OF REGISTERED
