WASHINGTON, D.C. JUNE 26 (MNS) --- "ON JUNE 17,1975, THE PEOPLE OF THE MARIANA ISLANDS DISTRICT FREELY EXERCISED THEIR RIGHT OF SELF-DETERMINATION IN A UNITED NATIONS OBSERVED PLEBISCITE AND CHOSE BY AN OVERWHELMING MARGIN TO APPROVE THE "COVENANT TO ESTABLISH A COMMONWEALTH OF THE NORTHERN MARIANAS IN POLITICAL UNION WITH THE UNITED STATES OF AMERICA,"

"THE DEPARTMENT OF THE INTERIOR AGAIN SENDS ITS WARMEST GREETINGS TO THE PEOPLE OF THE MARIANAS. PRESIDENT FORD WILL SOON BE SUBMITTING THE COVENANT TO THE UNITED STATES CONGRESS WITH HIS STRONG ENDORSEMENT. INDICATIONS WE HAVE RECEIVED POINT TOWARD SPEEDY CONSIDERATION OF AND ACTION ON THE COVENANT BY THE U.S. COMBRESS.

FINAL CONGRESSIONAL ACTION COULD COME AS EARLY AS THIS SUMMER. THEREFORE, THERE IS A PRESSING NEED FOR FURTHER, IMMEDIATE AND MORE DETAILED CONTINGENCY PLANNING FOR THE FULL SEPARATION OF THE MARIANAS DISTRICT FROM THE PEMAINDER OF THE TRUST TERRITORY AND FOR THE BEGINNING OF ITS TRANSITION TO A NEW COMMONWEALTH POLITICAL STATUS.

"I REGRET THAT THE SCHEDULE ENVISAGED EARLIER, NAMELY THAT FULL SEPARATE ADMINISTRATION OF THE MARIANAS WOULD OCCUP UPON ACCEPTANCE OF THE COVENANT IN THE POLITICAL STATUS PLEBISCITE, NOW MUST BE ADJUSTED TO PROVIDE OPPORTUNITY FOR NECESSARY DETAILED PLANNING FOR SEPARATE ADMINISTRATION AND TRANSITION WHILE THE COVENANT IS UNDER CONSIDERATION BY THE CONGRESS.

"I AM THEREFORE WITHHOLDING THE ISSUANCE OF A SECRETARIAL CROEF PROVIDING FOR FULL ADMINISTRATIVE SEPARATION PENDING CONGRESSIONAL CONSIDERATION OF THE COVENANT. DURING THIS TIME THE DETAILED PLANNING PROCESS IN CONSULTATION WITH THE LOCAL LEADERSHIP CAN BE COMPLETED.

"IN ORDER THAT THE FINAL PLANNING PROCESS LEADING TO A NEW POLITICAL STATUS FOR THE MARIANAS CAN BE STARTED RINGT AWAY, I HAVE REQUESTED THE HIGH COMMISSIONER TO RECONVENE THE AD HOC COMMITTEE ON ADMINISTRATION CONTINGENCY PLANNING FOR THE MARIANAS SEPARATION.

"FURTHER, WHILE MY NEW DIRECTOR OF TERRITORIAL AFFAIRS, MR. FRED M. ZEDER, IS IN THE MARIANAS DURING THE FIRST FEW DAYS OF JULY, I HAVE ASKED HIM TO MEET WITH THE AD HOC COMMITTEE TO DISCUSS ITS FURTHER WORK. HE WILL BE REQUESTING THAT THE COMMITTEE, WHICH IS CHAIRED BY DEPUTY HIGH COMMISSIONER COLEMAN, CONSULT FULLY AND MEET AS OFTEN AS NECESSARY WITH THE MARIANAS DISTRICT LEGISLATURES AND THE MARIANAS POLITICAL STATUS COMMISSION, BOTH OF WHICH ARE REPRESENTED ON THE COMMITTEE.

"MR. ZEDER AND MR COLENAN WILL ALSO CALL UPON EXPERTS IN THE TRUST TERRITORY AND MARIANAS DISTRICT GOVERNMENT TO PROVIDE THEIR SUPPORT AND SERVICES NOTS ON A PRIORITY BASIS.

"ADDITIONALLY THE COMMITTEE VILL CONSULT AS APPROPRIATE WITH OTHER INTERESTED PERSONS AND ORGANIZATIONS INCLUDING THE CONGRESS OF MICRONESIA AND VILL BE ABLE TO CONSIDER THEIR LEGITIMATE CONCERNS. DURING THE COURSE OF THE PLANNING PERIOD, THE CHAIRMAN OF THE AD HOC COMMITTEE WILL REPORT PERIODICALLY TO MR. ZEDER.

"THE AD HOC COMMITTEE WILL USE ITS PRELIMINARY REPORT WHICH WAS FILED LAST MAY 15 AS A BASIS FOR ITS FURTHER WORK AND CONSULATATIONS. IT WILL HAVE AS ITS PRINCIPAL RESPONSIBILITY PLANNING FOR THE ORGANIZATION OF A SEPARATELY ADMINISTERED GOVERNMENT OF THE MARIANAS DISTRICT TO COME INTO BEING UPON THE APPROVAL OF THE COVENANT BY THE UNITED STATES CONGRESS. MR. ZEDER WILL PROVIDE THE COMMITTEE WITH THE COMMENTS AND REVISIONS MADE ON ITS PRELIMINARY REPORT BY THE

OFFICE OF TERRITORIAL AFFAIPS. THE COMMITTEE'S FINAL REPORT TO THE DEPARTMENT OF THE

INTERIOR SHOULD COVER:

THE GOVERNMENT OF THE MARIAMAS DISTRICT UNDER SEPARATE ADMINISTRATION AND DURING PHASE I TRANSITION, WHICH IS THE TIME BETWEEN THE BEGINNING OF SEPARATE ADMINISTRATION AND THE INSTALLATION OF THE MARIAMAS. OWN ELECTED GOVERNMENT UNDER A NEW CONSTITUTION;

-RELATIONS BETWEEN THE MARIANAS AND THE TRUST TERRITORY HEADQUARTERS AND THE CONGRESS OF MICRONESIA AND THE OTHER DISTRICTS DURING SEPARATE ADMINISTRATION UNTIL TERMINATION

OF THE TRUSTEESHIP AGREEMENT; AND

-THE APPLICABILITY TO THE MARIANAS OF THE TRUST TERRITORY CODE AND FURTHER WORK ON THE SHARING OF GOVERNMENT SERVICES

BETWEEN THE MARIANAS AND HEADQUARTERS GOVERNMENT

"IN ADDITION TO THESE MATTERS, THE COMMITTEE WILL CONSIDER BUT WILL NOT BE LIMITED TO SUCH OTHER SUBJECTS AS:

-THE IMPACT ON THE MARIANAS OF A FUTURE RELOCATION OF THE TRUST TERRITORY HEADQUARTERS.

-A PHASED TEMETABLE FOR THE TRANSFERRAL OF GOVERNMENT SERVICES RESPONSIBILITIES FROM HEADQUARTERS TO THE MARIANAS GOVERNMENT INCLUDING THOSE PROGRAMS PRESENTLY ORIGINATING WITH THE CONGRESS OF MICRONESIA;

-PROVISIONS FOR THE CONTINUED EMPLOYMENT OF THOSE MARIANAS CITIZENS PRESENTLY WORKING FOR THE TRUST TERRITORY GOVERNMENT

WHO WISH TO REMAIN THERE; AND

-THE EARLY IMPLEMENTATION OF THE SPECIAL FUND PROVIDED FOR IN THE COVENANT FOR THE EDUCATION AND TRAINING OF MARIANAS CITIZENS TO ENABLE THEM TO MEET THE EXPANDED EMPLOYMENT CPPORTUNITIES WHICH WILL BECOME AVAILABLE DURING PHASE I TRANSITION AND UNDER THE NEW COMMONWEALTH GOVERNMENT.

"DURING THE TIME THE COVENANT IS UNDER CONSIDERATION BY THE UNITED STATES CONGRESS, THE ADMINISTRATION OF THE NORTHERN MARIANA LSLANDS WILL REMAIN UNCHANGED. THE HEADQUARTERS OF THE TRUST TERRITORY GOVERNMENT WILL REMAIN ON SAIPAN ISLAND.

THERE ARE NO INTENTIONS TO RELOCATE THE HEADQUARTERS OR TO REDUCE EMPLOYMENT LEVELS IN THE HEADQUARTERS STAFF IN THE NEAR FUTURE OR EVEN AFTER SEPARATION BECOMES EFFECTIVE. AT SUCH TIME AS THE COVENANT IS APPROVED BY THE CONGRESS, SEPARATE ADMINISTRATION WILL COMMENCE, A UNITED STATES RESIDENT COMMISSIONER FOR THE MARIANAS WILL BE APPOINTED, AND THE MARIANAS DELEGATION TO THE CONGRESS OF MICRONESIA WILL LEAVE THAT BODY AND JOIN THE MARIANAS DISTRICT LEGISLATURE AS MEMBERS-AT-LARGE.

"ALSO AT THAT TIME, THE AGREED PHASE I TRANSITION PROGRAM FOR THE MARIANAS WILL BEGIN AND THE 1.5 MILLION DOLLARS ALPEADY AUTHORIZED BY THE UNITED STATES CONGRESS WILL BE MADE AVAILABLE FOR THE ESTABLISHMENT AND FUNCTIONING OF THE OFFICE OF TRANSITIONAL PLANNING AND STUDIES AND FOR OTHER TRANSITION RELATED ACTIVITIES.

"CLEARLY, THE NEXT FEW WEEKS WILL BE IMPORTANT ONES FOR THE MARIANAS DISTRICT LEGISLATURE. I HAVE ASKED MR. ZEDER TO REQUEST A MEETING WITH THE LEADERSHIP OF THE LEGISLATURE AND TO BRING TO THEIR ATTENTION SEVERAL VITAL ISSUES WHICH SEEM TO REQUIRE THAT BODY'S THOUGHTFUL CONSIDERATION AND ACTION.

"AMONG THESE IS A DETAILED REVIEW OF THE TRUST TEREITORY CODE TO DETERMINE WHERE ANENDING PROVISIONS ARE NECESSARY WHEN A FULL SEPARATE ADMINISTRATION OCCURS. THE LEGISLATURE WILL ALSO OF COURSE NEED TO REORGANIZE ITS COMMITTEE AND STAFF STRUCTURE TO ACCOMODATE NEW MEMBERS-AT-LARGE AND ITS GREATLY

EXPANDED RESPONSIBILITIES IN THE AREAS OF BUDGET AND FINANCE.

"AS SOON AS THE LEGISLATURE ORGANIZES THE MARIANAS PUBLIC LAND CORPORATION ACCORDING TO THE PROVISIONS OF SECRETARIAL ORDER NO. 2969 AND THE RECENTLY PASSED ENABLING LEGISLATION, TITLE TO PUBLIC LANDS IN THE MARIANAS DISTRICT CAN BEGIN TO BE TRANSFERRED.

"THE LEGISLATURE MAY WISH ALSO TO PLAN FOR LEGISLATION CALLING A MARIANAS CONSTITUTIONAL CONVENTION AND PEFERENDUM AND TO ESTABLISH PROCEDURES FOR ITS COORDINATION WITH THE OFFICE OF TRANSITIONAL PLANNING AND STUDIES AND THE JOINT TRANSITION COMMISSION, BOTH OF WHICH WERE PROVIDED FOR IN THE AGREED PHASE/I TRANSITION PLAN.

"THE ACTIONS I HAVE OUTLINED SHOULD HELP US IN THE FUETHER PLANNING NECESAARY FOR FULL SEPARATE ADMINISTRATION AND THE

BEGINNING OF PHASE I TRANSITION. UPON APPROVAL OF THE COVENANT BY THE U.S. CONGRESS, I WILL ISSUE A NEW SECRETARIAL ORDER PROVIDING FOR THE SEPARATE ADMINISTRATION OF THE MAPIANAS DISTRICT. THIS ORDER, ALONG WITH THE INTERNAL ORGANIZATION OF THE INTERIM SEPARATE ADMINISTRATION GOVERNMENT, WILL BE BASED IN LARGE PART ON THE FINAL REPORT OF THE AD HOC COMMITTEE.

"I SHOULD LIKE TO THANK TH AD HOC COMMITTEE FOR ITS EXCELLENT PRELIMINARY REPORT, AND I WILL DEEPLY APPRECIATE THE CONTINUING BEST EFFORTS OF THE MARIANAS LEADERSHIP AND THE TRUST TERRITORY AND THE MARIANAS DISTRICT GOVERNMENT AS WE

MOVE TOGETHER TO MAKE FINAL PLANS."

(SENATOR FONG'S STATEMENT ON MARIANAS PLEBSCITE RESULT)
WASHINGTON, JUNE 26 (MNS) --- IN A STATEMENT ON THE SENATE
FLOOR JUNE 24, HAWAII SENATOR HIRAM FONG REVIEWED THE STATISTICS
IN THE FINAL REPORT OF PLEBISCITE COMMISSIONER ERWIN CANHAM
AND NOTED THAT 78.8 PERCENT OF VALID VOTES CAST APPROVED THE
COMMONWEALTH COVENANT AND THAT MORE THAN 93 PERCENT OF THE

"IN THE BUDGET SHEET DISTRIBUTED TO EVERY HOUSE MEMBER, THE LEGISLATIVE COUNSEL SHOWS THREE VACANT POSITIONS FOR STAFF ATTORNEY.

HE CHARGED THAT THE LEGISLATIVE COUNSEL IS "SEGINNING TO RUN THE CONGRESS."

ASKED BY REPRESENTATIVE LAMBERT AAFIN (TPUK) TO ELABORATE ON HIS ATATEMENT, RASA SAID THAT "MAJOR DECISIONS" ARE MADE BY THE LEGISLATIVE COUNSEL AND STAFF ATTORNEYS AND NOT MEMBERS OF CONGRESS.

(SENATE PASSES SALARY BILL)

SAIPAN, JUNE 26 (MNS) --- THE SENATE WEDNESDAY MIGHT MET FOR ONE HOUR TO CONSIDER THE NEW BASE SALARY SCHEDULE FOR GOVERNMENT EMPLOYEES AND PASSED IT ON SECOND AND FINAL READING AND SENT IT . TO THE HOUSE FOR ITS CONSIDER ATION:

THE NEW ADMINISTRATION-SPONSORED SALARY SCHEDULE, IF PASSED BY THE CONGRESS OF MICROWESIA AND SIGNED INTO LAW BY THE HIGH COMMISSIONER, WILL PAISE THE SALARIES OF THE TRUST TERRITORY GOVER "MENT EMPLOYEES A "CONSIDERABLE" AMOUNT.

IN THE GENERAL DEBATE ON THE SALARY MEASURE, MAPIAMAS -SENATORS OLYMPIO BORJA AND PEDRO TENORIO BOTH DELIVERED BRIEF REMARKS, SUPPORTING THE SALARY SCHEDULE.

UPGING THE PASSAGE OF THE BILL. SENATOR BORJA STRESSED THE NEED FOR INCREASING THE SALARIES OF THE EMPLOYEES IN VIEW OF THE RISING COST OF LIVING NOW APPARENT THROUGHOUT MICHONESIA. MORE PERSISTENT AND VOCAL IN HIS REMARKS, SENATOR TENOPIO SAID THAT THE SALARY BILL IS A STEP IN THE RIGHT DIFECTION AND HE URGED BOTH THE CONGRESS OF MICRONESIA AND THE ADMINISTPATION

TO JOINTLY WORK TOGETHER TO MAKE THE SALARY BILL A REALITY.
SAYING THAT THE CERTAIN BEANCHES OF THE GOVERNMENT MUST
"SACRIFICE TOGETHER", THE MARIANAS SENATOR PROPOSED SEVERAL
STEPS TO BE UNDERTAKEN BY THE CONGRESS AND THE ADMINISTRATION
IN ORDER TO IMPLEMENT THE NEW BASE SALARY SCHEDULE.

FOR THE ADMINISTRATION, HE SAID THAT DEE TO CURRENT BUDGET APY CONSTRAINTS NOW AFFECTING THE GOVERNMENT, HE PROPOSED, AMONG OTHER THINGS, THAT THE BENEFITS GOING TO THE CHILDPEN OF THE TT GOVERNMENT'S EXPATPLATES BE ELIMINATED, AND THAT THE ADMINISTERATION TAKE STEPS TO HIPE GUALIFIED MICEGNESIANS TO FEPLACE THE EXPATRIATES.

THIS FELLOW SENATORS TO LOWER THEIR OWN SALAPIES. IF SIEPS ARE
NOT TAKEN, THE SALARY BILL MAY NOT BECOME A REALITY AND THE
CONGRESS MAY NOT BE DOING A GOOD SERVICE TO THE PEOPLE OF
MICRONESIA. TENORIO EMPHASIZED.
