1. AT AN INFORMAL MEETING OF FRENCH, UK, US, MISOFFS AND TRUSTEESHIP COUNCIL SECRETARY ABEBE CALLED BY TC PRESIDENT MURRAY (UK) TO DISCUSS THE UPCOMING VISITING MISSION TO THE TRUST TERRITORY OF THE PACIFIC ISLANDS (TTPI), ABEBE PRESENTED A DRAFT PROVISIONAL AGENDA FOR THE FORTH-THIRD SESSION OF THE TC (TRANSMITTED BELOW). INCLUSION OF AGENDA ITEMS 10, 11, 12 AND 13 WAS DISCUSSED.

2. IN RESPONSE TO COMMENTS BY ABEBE AND USUN MISOFF, MURRAY SAID HE THOUGHT THAT ITEMS 10 AND 11, WHICH DEAL WITH RACIAL DISCRIMINATION AND RACISM SHOULD BE EITHER DROPPED FROM THE AGENDA OR COMBINED IN A SINGLE ITEM WHICH WOULD ALLOW TC MEMBERS

TO GO ON RECORD AS TO EXACTLY WHAT THEY MEAN BY RACISM.

3. IN RESPONSE TO AN EXPLANATION BY USUN MISOFF OF THE LACK OF COMPETENCE OF THE SPECIAL COMMITTEE ON DECOLONIZATION TO CONSIDER THE TTPI, MURRAY AGREED THAT ITEM 13 SHOULD BE DROPPED. (THIS ITEM WAS APPROPRIATE LAST YEAR SINCE THE SPECIAL COMMITTEE DID HAVE A VALID MANDATE TO REVIEW PAPUA NEW GUINEA.) MURRAY SAID HE THOUGHT ITEM 12 SHOULD PROBABLY REMAIN ON THE AGENDA. GARRIGUE-GUYONNAUD (FRANCE) AGREED.

4. ABEBE POINTED OUT THAT MURRAY HAS A MONTH AT LEAST TO DECIDE ON THE PROVISIONAL AGENDA WHICH IS THE RESPONSIBILITY OF THE SECGEN IN CONSULTATION WITH PRESIDENT OF THE TC. MURRAY SAID HE WOULD CONSULT WITH TC MEMBERS ON THE AGENDA BEFORE CONVEYING FINAL VIEWS TO THE SECRETARIAT.

5. COMMENT: USUN IS PRESENTLY REVIEWING THE FOLLOWING AGENDA WITH A VIEW TOWARDS SEEKING THE EXCLUSION OF ALL ITEMS WHICH IMPLY REPORTING TO THE GENERAL ASSEMBLY ON THE TRUST TERRITORY OR ANY LINKAGE WITH THE ZIONISM RESOLUTION. USUN IS ALSO ATTEMPTING TO ENSURE THAT NO ITEM RELATED TO THE TC APPEARS ON THE PRELIMINARY PROVISIONAL AGENDA OF THE THIRTY-FIRST GENERAL ASSEMBLY WHICH IS SCHEDULED TO BE PUBLISHED ON FEBRUARY 15.
