SAIPAN, JAN. 20 (MNS) --- DIRECTOR OF TERRITORIAL AFFAIRS FRED M. ZEDER ATTENDED THE WEEKLY CABINET MEETING TUESDAY WITH HIGH COMMISSIONER JOHNSTON AND HIS STAFF AND TOLD THEM THAT OPEN COMMUNICATIONS BETWEEN TTPI AND WASHINGTON IS IMPORTANT "NOT FOR THE PURPOSE OF CRITICIZING PAST PERFORMANCES

BUT FOR GETTING ON WITH THE KOB AHEAD OF US."

ZEDER TOLD THE CABINET MEMBERS THAT HE WAS "PROUD AND PLEASED AT THE PROGRESS MADE HERE IN THE PAST FEW MONTHS" AND SAID THAT HE REGRETTED THE PRESS COVERAGE OF HIS RECENT REPORT WHICH HE SAID "DID NOT ACCURATELY REFLECT THE PURPOSE OF THE EXERCISE."

HE SAID THE BALANCE OF THE REPORT WAS ON "ACTIONS TAKEN, ACTIONS PENDING TO SOLVE PROBLEMS" AND CALLED ON THE CABINET MEMBERS TO ADRESS THEMSELVES TO THE "MULTITUDE OF THINGS THAT NEED TO BE DON" IN THE FUTURE AND NOT DWELL ON RECRIMINATIONS ABOUT THE PAST.

THE RECENTLY APPOINTED DIRECTOR OF TERRITORIAL AFFAIRS SATD THAT THE MAIN EMPHASIS FOR THE FUTURE WOULD BE TO ACHIEVE FOROMIC SELF SUFFICIENCY FOR MICRONESIA AND THAT HE COULD ENVISION THE TIME "WHEN THESE ISLANDS WILL BE ABLE TO ACHIEVE A STANDARD OF LIVING AND AN OPPORTUNITY FOR GROUTH THEY DESERVE -- BUT ONLY BY A GREAT EFFORT ON YOUR PART."

IN CLOSING, ZEDER PLEDGED THE "FULL AND TOTAL COOPERATION OF WASHINGTON" IN PROGRAMS FOR ECONOMIC DEVELOPMENT. HE SAID THAT WASHINGTON UNDERSTANDS THE PROBLEMS HERE AND "WISHES TO

COMMISSIONER EDWARD E. JOHNSTON'S ADMINISTRATION WERE DELIVERED TUESDAY MORNING IN THE HOUSE OF REPRESENTATIVES OF THE CONGRESS OF MICRONESIA.

ONE WAS BY REPRESENTATIVE OSCAR C. RASA FROM THE MARIANAS, WHO SHARPLY CRITICIZED THE HIGH COMMISSIONER FOR "INCOMPENTENCE" IN HIS JOB AND THE PLACING OF "UNQUALIFIED" MICRONESIANS IN THE TOP LEVEL POSITIONS OF THE TRUST TERRITORY GOVERNMENT.

THE UTHER WAS A LETTER WRITTEN BY FRESHMAN CONGRESSMAN HERMAN TO PALACIOS ALSO FROM THE MARIANAS TO FRED M. ZEDER. THE BILLS WERE: A MEASURE TO RAISE MOTOR VEHICLE OPERATORS LICENSE FEES FROM \$1.50 A YEAR TO \$3, (HB 6-366); AND A BILL TO LEGALIZE SLOT MACHINES IN THE TRUST TERRITORY (HB 6-369).

CONGRESSMAN POLYCARP BASILIUS OF PALAU, CHAIRMAN OF THE JUDICIARY AND GOVERNMENTAL RELATIONS COMMITTEE TO WHICH THE BILL WAS REFERRED, SUGGESTED THAT THE COMMITTEE SHOULD STUDY THE MEASURES SINCE THEY HAD ALREADY BEEN


GUERRERO SAID AFTERWARD THAT HE MIGHT INTRODUCE THE SAME BILLS AGAIN AFTER HE MAKES FURTHER STUDIES.

IN THE SENATE, A BILL TO MAKE A TECHNICAL CORRECTION IN PUBLIC LAW 6-8 (SB 6-217) PASSED SECOND READING AND WAS SENT TO THE HOUSE FOR FURTHER CONSIDERATION. THE MEASURE RELATES TO MICRONESIA'S ANNUAL CONTRIBUTION TO THE SOUTH PACIFIC COMMISSION. THE BILL, SIGNED LAST YEAR BY THE HIGH COMMISSIONER, REFERRED TO THE SOUTH PACIFIC COMMISSION AS THE SOUTH PACIFIC "CONFERENCE." THE BILL IS TO AMEND THE LAW TO THE PROPER FORM.

TWO JOINT RESOLUTIONS WERE ADOPTED IN THE SENATE.
THEY BOTH CONVEYING SYMPATHY AND CONDOLENCES TO THE

SOMEONE OTHER THAN MYSELF ADDRESSING YOU NEXT YEAR, IF THE TREND OF OUR POLITICAL ASPIRATIONS MATERIALIZE. NEVERTHELESS, THE SEVEN YEARS BEING YOUR CHIEF EXECUTIVE IN OUR DISTRICT GOVERNMENT, AND MY ASSOCIATION WITH YOU, THE CHALLENGES OF THE OFFICE AND DEMANDS WHICH WERE BESTOWED UPON THIS OFFICE SHALL FOREVER BE REGARDED BY MYSELF AS REWARDING PERSONAL EXPERIENCES AND GRATIFICATION."

DISTAD ADA IN HIS MESSAGE CALLED THE YEAR 1975 AN "EXCITING YEAR, ...PERHAPS ONE OF THE MOST PROSPEROUS WHEN COMPARED TO PREVIOUS YEARS." ENUMERATING THE HIGHLIGHTS OF 1975, ADA NOTED THE MARIANAS POLITICAL DEVELOPMENT AND ADVANCEMENT WHICH "... AFTER A SERIES OF STATUS NEGOTIATIONS, CULMINATED IN THE SIGNING OF THE AGREEMENT REACHED BETWEEN THE DELEGATIONS OF THE UNITED STATES AND THE MARIANAS DISTRICT... THE COVENANT TO

ESTABLISH A COMMONWEALTH OF THE NORTHERN MARIANAS."

INCLUDED IN THIS POLITICAL ADVANCEMENT WAS THE
"ESTABLISHMENT OF FULL-TIME STATUS TO MEMBERS OF THE
MARIANAS DISTRICTLEGISLATURE...A CONCEPT HEAVILY
SUPPORTED IN VIEW OF THE ESSENTIAL ROLE THIS BODY WILL
PLAY IN THE NEW GOVERNMENT OF THE MARIANAS, AND ALSO
THAT THE MEMBERS (LEGISLATORS) COULD DECIDE IN WHICH
BRANCH OF THE GOVERNMENT THEY WOULD PREFER TO DEVOTE THEIR

MENTIONING THE DRAFO CONSTITUTION FOR THE FUTURE FEDERATED STATES OF MICRONESIA, ADA HOPED THAT INSPITE OF THE POLITICAL DIFFERENCES THERE WOULD BE MUTUAL CONTINUING COOPERATION AND ASSISTANT BETWEEN THE MARIANAS AND MICRONESIAN... "SUCH FRIENDSHIP SHOULD BE ETERNALLY CARRIED ON."

IN THE AREA OF DEVELOPMENT AND ADVANCEMENT IN EDUACATION, ADA NOTED THE FOLLOWING: COMPLETION OF 12 CLASSROOMS--2 ON ROTA, ONE ON TINIAN AND THE REST ON SAIPAN; 20 TEACHERS ARE ON EDUCATIONAL LEAVE ATTENDING COLLEGE; 180 SCHOOL PERSONNEL AND OTHER INTERESTED INDIVIDUALS

THREE STUDENTS HAVE RETURNED WITH MASTER'S DEGREES,
TWELVE WITH BACHELORS, TWO WITH ASSOCIATE DEGREES AND
TWO GRADUATED FROM LAW SCHOOLS.

EDUCATIONAL CURRICULUM DEVELOPMENT HAS COME OUT WITH TWO 4TH GRADE SOCIAL STUDY BOOKS: OUR MARIANAS, 352 PAGES (TEACHER'S EDITION) THE MARIANAS ALBUM, 166 PAGES (STUDENT BOOK). THE MICRONESIAN CULTURAL AND LANGUAGE PROJECT BEGUN IN SAIPAN TWO YEARS AGO HAS EXTENDED TO INCLUDE TINIAN AND ROTA SCHOOLS. THE MARIANAS BILINGUAL PROGRAMS IN MARIANAS DISTRICT HAVE MADE GREAT ADVANCES.

TURNING TO THE NEED FOR MARIANAS YOUTH, ADA INCLUDED THE CONSTRUCTION OF YOUTH RECREATIONAL SUB-CENTERS ON SAIPAN, TINIAN AND ROTA MADE POSSIBLE THROUGH THE LEGISLATURE AND THE CONGRESS OF MICRONESIA FUNDS; AND THE ESTABLISHMENT OF THE MARIANAS SPORTS COUNCIL.

SPEAKING OF GENERAL ECONOMIC ACCOMPLISHMENTS, ADA SA'D THE MARIANAS DISTRICT "HAS MADE VERY SIGNIFICANT

ACCORDING TO RASA, THE STAFF REPORT OF SEN. JACKSON'S COMITTEEPIS "IN FACT AN INVESTIGATION OF A SERIES OF MISTAKES AND MISMANAGEMENT" OF THE TT GOVERNMENT.

THE MARIANAS CONGRESSMAN NOTED THAT SOME TIME AGO, THE MARIANA ISLANDS DISTRICT LEGISLATURE ADOPTED A RESOLUTION CALLING FOR THE REMOVAL OF THE HICOM.
