1. THE FOLLOWING "PETITIONS" WERE CIRCULATED ON FEBRUARY 5 AS TRUSTEESHIP COUNCIL DOCUMENTS:

A. T/PET.10/95, JAPAN CONGRESS AGAINST A AND H BOMBS LETTER DATED MAY 24, 1975 REQUESTING THE SECRETARY GENERAL TO CANCEL THE NORTHERN MARIANAS PLEBISCITE.

B. T/PET.10/96, CONFERENCE FOR A NUCLEAR FREE PACIFIC RESOLUTION V (NO DATE) URGING THE TRUSTEESHIP COUNCIL TO DETERMINE THAT NORTHERN MARIANAS PLEBISCITE IS "NOT A LEGITIMATE ACT OF SELF-DETERMINATION."

C. T/PET.10/97, WAR RESISTERS' INTERNATIONAL LETTER DATED JUNE 6, 1975 SUPPORTING THE CONFERENCE FOR A NUCLEAR FREE PACIFIC PETITION.

D. T/PET.10/98, LETTER FROM DELEGATE TO ECONOMIC AND SOCIAL COUNCIL OF WAR RESISTERS' INTERNATIONAL URGING THAT TRUSTEESHIP COUNCIL DETERMINE THAT NORTHERN MARIANAS PLEBISCITE "DOES NOT CONSTITUTE A LEGITIMATE ACT OF SELF-DETERMINATION."

2. TRUSTEESHIP COUNCIL ALSO CIRCULATED THE FOLLOWING COMMUNICATIONS:

A. T/COM.10/L.164, THIRTEENTH TINIAN MUNICIPAL COUNCIL RESOLUTION 08-1975, DATED MAY 21, 1975 STATING THAT THE PEOPLE OF TINIAN SUPPORT US COMMONWEALTH AND THAT JOSE CRUZ AND BERNARD HOFSCHEIDER ARE THE ONLY AUTHORIZED OFFICIAL SPOKESMEN ON POLITICAL STATUS MATTERS.

B. T/COM.10/L.166, LETTER FROM CAMPAIGN FOR NUCLEAR DISARMAMENT EXPRESSING HOPE THAT THE NORTHERN MARIANAS AND "ALL OTHER SUCH TRUST AREAS SHALL ACHIEVE INDEPENDENCE AND BE FREE FROM THE IMPOSITION OF NUCLEAR TESTING AND FOREIGN MILITARY BASES."

C. T/COM.10/L.167, LETTER FROM THE GREENPEACE FOUNDATION OF NEW ZEALAND EXPRESSING CONCERN ABOUT "PHYSICAL AND MENTAL ENVIRONMENT DAMAGE" THAT THE NORTHERN MARIANAS MAY SUFFER IF THE US "TAKES CONTROL."
