SAIPAN, MAR 3 (MNS)---THERE WERE BOTH ACCOMPLISHMENTS AND DISAPPOINTMENTS IN THE 1976 CONGRESS OF MICRONESIA SESSION WHICH ENDED THIS WEEK ON SAIPAN, THESE WERE REFLECTED IN THE NUMBER OF MAJOR BILLS PASSED AND SENT TO THE HIGH COMMISSIONER AND IN THE NUMBER POSTPONED.

ACCORDING TO THE UNOFFICIAL TALLY OF THE MICRONESIAN NEWS SERVICE, A TOTAL OF 51 BILLS WERE APPROVED AND SENT TO THE HIGH COMMISSIONER DURING THIS SESSION FOR HIS ACTION 32 OF THEM ON THE FINAL DAY. OF THESE, SIX HAVE BEEN SIGNED INTO LAW.

ON THE FINAL DAY (MONDAY, MARCH 1), A BILL DESIGNATING PONAPE DISTRICT AS THE SITE OF THE FUTURE MICRONESIAN CAPITAL WAS POSTPONED UNTIL THE SPECIAL SESSION, IF ONE IS TO BE CALLED. THE SENATE VOTED TO REJECT THE HOUSE AMENDMENTS ON THIS PARTICULAR BILL. THE HOUSE AMENDMENTS WUURL EXCLUDE PALAU DISTRICT FROM MICRONESIA AND EARMARK \$59,000 TO PERFORM FEASIBILITY STUDIES FOR THE CAPITAL OF PALAU. A CONFERENCE COMMITTEE CONSISTING OF MEMBERS FROM BOTH HOUSES WORKED OUT A COMPROMISE.

"THE ISSUE IS COMPLEX," THE COMMITTEE REPORTED, "AND

THE HOUSE OF REPRESENTATIVES ALSO POSTPONED ACTION ON A BILL TO INCREASE THE TAX ON WAGES AND SALARIES FROM YWO PERCENT TO SIX PERCENT, (SB 6-287). THE SENATE APPROVED THE BILL LAST WEEK BUT NOT WITHOUT SOME OPPOSITION.

ON THE FINAL DAY, THE BILL MET STRONG OPPOSITION FROM THE MARIANAS, MARSHALLS AND PALAU DELEGATIONS. LED BY REP. OSCAR C. PASA, THE MARIANAS DELEGATION STRONGLY OBJECTED TO THE BILL BECAUSE THERE ARE MARIANAS CITIZENS TYCL WORKING AT TRUST TERRITORY HEADQUARTERS THAT WILL IS AFFECTED IF THE MARIANAS IS SEPARATED ADMINISTRATIVELY ROM THE REST OF MICRONESIA. "THE PROPOSED RATE OF TAXATION WOULD THEN BE ASSESSED ON THE ADDITIONAL AMOUNT BEYOUD THE \$2,000," MOSES EXPLAINED.

EARLIER IN THE SESSION, A BILL TO CREATE A COMMITTEE ON POLIFICAL EDUCATION PROGRAMS AND APPROPRIATE \$45,000 FOR ISS FUNCTIONS (SB 6-287) WAS DEFEATED IN THE LOWER CHAMBER. SOME MEMBERS CONTENDED THAT THE PUBLIC AFFAIRS THE COMMITTEE AND CREATION OF SUCH A COMMITTEE WOULD TOUPLICATE" WORK.

A BILL TO PROVIDE FOR THE PAYMENT OF EXPENSES OF JURY TRIAL WITHIN THE TRUST TERRITORY (SB 6-232) WAS ALSO PUT OFF UNTIL THE SPECIAL SESSION.

HE SAID IF THIS TREND CONTINUES INTO THE FUTURE, THERE MAY BE SERIOUS PROBLEMS IN THE SOCIAL AND ECONOMIC SITUATION IN MICRONESIA.

A UNIVERSITY PROFESSOR OF LABOR ECONOMICS FOR 25 YEARS AND, MOST RECENTLY, AN ECONOMIC ADVISOR FOR THE ASIAN <sup>0</sup> REGIONAL OFFICE OF THE INTERNATIONAL LABOR ORGANIZATION, KNOWLES HAS BEEN SPENDING MOST OF HIS TIME IN THE TRUST TERRITORY COLLECTING INFORMATION, MEETING OFFICIALS AND UN SPECIALISTS IN ORDER TO BETTER UNDERSTAND THE ECONOMY OF MICRONESIA.

QUESTIONED ABOUT THE DIFFERENCES BETWEEN A SOCIALIST ECONOMY AND A CAPITALIST ONE IN THE MANPOWER AREA, THE INTERNATIONAL LABOR ORGANIZATION SPECIALIST SAID THAT IN SOCIALIST COUNTRIES, PRICES ARE FIXED BY THE GOVERNMENT, PROFESSIONS ARE NOT OFTER CHOSEN BY THE PEOPLE THEMSELVES BUT BY THE GOVERNMENT, "ONE ADVANTAGE OF THIS," HE SAID, "WAS THAT UNDER SOCIALISM, THERE WOULD NOT BE THE LARGE NUMBERS OF PEOPLE MOVING FROM THE OUTER ISLANDS TO THE DISTRICT CENTERS, THE GOVERNMENT COULD JUST TELL THEM TO STAY WHERE THEY ARE."

HE SAID WHATEVER PLANS THE NEW DOTA MAY HAVE, THEY "MUST BE CONSISTENT WITH THE CONSTITUTION OF THE FUTURE FEDERATED STATES OF MICRONESIA AND WITH THE WISHES" OF THE CONGRESS OF MICRONESIA.

CONGRESSMAN HARUO ACKNOWLEDGED THAT SOME OF HIS COLLEAGUES BELIEVE IT IS TIME THAT MICRONESIA OPEN. ITSELF FOR POTENTIAL FOREIGN INVESTORS. HE SAID HE DISAGREES WITH SUCH A MOVE. HE SUGGESTED THAT MICRONESIA MUST FIRST INCREASE ITS TAX SYSTEM TO GENERATE MORE REVENUES AND MAKE USE OF FOREIGN AID ALREADY OFFERED BY SOME PACIFIC NATIONS. HARUO ALSO MENTIONED A REPORT FROM THE MICRONESIAN <u>CLAIMS CO</u>MMISSION WHICH SAYS IT IS NOW RUNNING A DEFICIT OF ABOUT \$32=MILLION DOLLARS WHICH IT NEEDS TO PAY LONG= OVERDUE CLAIMS TO MICRONESIANS. HE URGED THAT CONGRESS URGE THE UNITED STATES AND JAPAN'S GOVERNMENTS TO COVER THIS DEFICIENCY.

CONGRESSMAN HARUO NOTED THAT MICRONESIANS HAVE ONLY RECEIVED SIXTEEN PERCENT OF THEIR TOTAL CLAIMS FILED AND TO WHICH THEY MUST SIGN A "RELEASE DOCUMENT." HE POINTED OUT AFFIXING SIGNATURES TO SUCH A DOCUMENT, IN EFFECT,
