(TRUSTEESHIP COUNCIL REAFFIRMS POSITION)

UNITED NATIONS, JULY 26 (MNS) --- THE U.N. TRUSTEESHIP

COUNCIL RECENTLY REAFFIRMED THE RIGHT OF THE PEOPLE OF

THE TRUST TERRITORY OF THE PACIFIC ISLANDS, MICRONESIA, TO

THE TRUST TERRITORY OF THE PACIFIC ISLANDS, MICRONESIA, TO SELF-DETERMINATION, INCLUDING INDEPENDENCE. HOWEVER, THE COUNCIL AFFIRMED ITS CONVICTION THAT THE POLITICAL UNITY OF THE CAROLINE AND MARSHALL ISLANDS SHOULD BE MAINTAINED, ACCORDING TO A U.N., PRESS RELEASE.

MICRONESIA IS THE ONLY TERRITORY REMAINING UNDER

THE UNITED . NATIONS TRUSTEESHIP SYSTEM.

THE COUNCIL RECOGNIZED THAT THE PEOPLE OF THE NORTHERN MARIANAS, "IN THE FREE EXERCISE OF THEIR RIGHT TO SELF-DETERMINATION", HAD BY A LARGE MAJORITY APPROVED A COVENANT TO ESTABLISH A COMMONWEALTH IN POLITICAL UNION WITH THE UNITED STATES. THE COUNCIL FURTHER TOOK NOTE OF U.S. ASSURANCES THAT CERTAIN PROVISIONS OF THE COVENANT WOULD NOT TAKE EFFECT UNTIL AFTER THE TERMINATION OF THE TRUSTEESHIP AGREEMENT, AND THAT IT WAS THE INTENTION OF THE U.S. THAT THE AGREEMENT BE TERMINATED SIMULTANEOUSLY FOR BOTH THE NORTHERN MARIANAS AND THE REMAINING DISTRICTS.

(NINE RECEIVES INCENTIVE AWARDS) -

SAIPAN, JULY 26 (MNS) --- NINE EMPLOYEES OF THE TRUST TERRITORY GOVERNMENT, BOTH AT HEAD QUARTERS AND DISTRICTS, RECENTLY RECEIVED INCENTIVE AWARDS FOR THEIR OUTSTANDING SERVICES AND EXCELLENT PERFORMANCE. FOUR OF THE RECEPIENTS ARE FROM PALAU DISTRICT AND THE REST ARE EMPLOYED AT HEADQUARTERS.

ACCORDING TO ALONZO IGISOMAR, ASSISTANT CHIEF OF EMPLOYMENT/EMPLOYEE RELATIONS DIVISION AND WHO ALSO SERVES AS ADVISOR TO HEADQUARTERS INCENTIVE AWARDS COMMITTEE, SAID THE COMMITTEE MADE ITS FINAL RECOMMENDATION ON JUNE 23, 1976 TO THE OFFICE OF THE HIGH COMMISSIONER. JUAN A. SABLAN, THEN ACTING DEPUTY HIGH COMMISSIONER, APPROVED THE NAMES OF THE NINE RECEPIENTS JULY 1.

IGISOMAR SAID THAT THE USUAL PROCEDURE FOR INCENTIVE AWARDS IS FOR EACH DEPARTMENT TO MAKE THE RECOMMENDATIONS FOR ITS EMPLOYEIS TO THE DISTRICT INCENTIVE AWARDS COUMITTEE. THE DISTRICT COMMITTEE THEN MAKES SELECTIONS AND FORWARD ITS RECOMMENDATIONS TO THE HEAD QUARTERS INCENTIVE AWARDS—COMMITTEE. THE HEADQUARTERS COMMITTEE MAKES THE FINAL SCREENING AND RECOMMENDATION TO THE HIGH COMMISSIONER.
