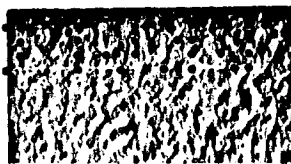

REF TTPI MESSAGE 523 ON PREPARATION OF 1976 UN REPORT AND NORTHERN MARIANAS MESSAGE 002 ON SAME SUBJECT. TRUSTEESHIP AGREEMENT HAS NOT BEEN ALTERED BY APPROVAL OF NORTHERN MARIANAS COVENANT. THERE IS ONLY ONE TRUST TERRITORY OF THE PACIFIC ISLANDS OF WHICH N. MARIANA ISLANDS REMAINS A PART UNTIL TERMINATION OF TRUSTEESHIP AGREEMENT. THEREFORE OFFICIAL REPORTING TO UN SHOULD FOLLOW SAME PATTERN AS DURING PERIOD WHEN NAVY ADMINISTERED FORMER SAIPAN DISTRICT WITH ONE INTEGRATED REPORT. EXCEPTION IS THAT FORMER SAIPAN DISTRICT SHOULD BE IDENTIFIED AS NORTHERN MARIANAS GOVERNMENT IN TEXT AND IN STATISTICAL TABLES AND ALSO APPROPRIATE DISTINCTION MADE IN TEXT THAT RESIDENT COMMISSIONER, NMI PLAYS SAME ROLE AS HIGH
