C-24 REPS. NONE OF THEM BELIEVE THAT
THE C-24 WILL TAKE ANY ACTION IN RESPONSE TO THE PE-
TITION'S REQUEST THAT THE C-24 "RECOMMEND TO THE NEXT
SESSION OF THE GA THAT IT PASS A RESOLUTION CONDEMNING THE
EFFORTS OF THE UNITED STATES TO ESTABLISH A NEW COLONIAL TERR-
ITORY IN ONE OF THE ARCHIPELAGOS OF MICRONESIA, THE NORTHERN
MARIANA ISLANDS."
