URGENT CONCERN IS THAT ARTICLE XIII SECTION 3 NOT INCLUDE ANY MONETARY RELIEF.

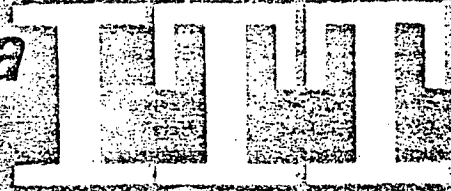
