1. ON AUGUST 20, THE C-24 ADOPTED ALL THE REPORTS OF ITS
SUB-COMMITTEE ON SMALL TERRITORIES INTRODUCED AT THE
AUGUST 19 MEETING (REFTEL) AND THE REPORT ON THE TT INTRO-
DUCED ON AUGUST 20. THE CHINESE REPRESENTATIVE EXPRESSED
CHINA'S RESERVATIONS ON ALL PARAS DEALING WITH MILITARY
BASES. HE STATED CHINA'S POSITION THAT THERE SHOULD BE NO
MILITARY BASES ON ANY TERRITORY. WITH THE ABOVE EXCEPTION,
THERE WAS NO COMMENT ON ANY OF THE REPORTS AND ALL WERE ADOPTED.

2. THE SECRETARIAT ISSUED A CORRIGENDUM TO THE SUB-COMMITTEE'S REPORT ON THE TT DELETING THE STATEMENT THAT THE ADMINISTERING AUTHORITY HAD PARTICIPATED IN THE DELIBERATIONS ON THE TT, WHICH HAD ERONEOUSLY CREPT INTO THE FINAL VERSION OF THE REPORT.

3. DURING THE SUB-COMMITTEE'S CONSIDERATION OF THE REPORT ON THE TT (DURING WHICH US REP ABSTAINED HIMSELF), BULGARIAN MISOFF GARBALOV CRITICIZED THE ADMINISTERING AUTHORITY FOR NOT PARTICIPATING IN THE C-24'S CONSIDERATION OF THE TT AND FOR NOT PROVIDING INFORMATION ON THE TT TO THE C-24. IVORY COAST MISOFF KOUAME, CHAIRMAN OF THE SUB-COMMITTEE ON SMALL TERRITORIES, ASKED ACTING C-24 CHAIRMAN VRAALSEN (NORWAY) IF HE HAD BEEN IN CONTACT WITH THE PRESIDENT OF THE TC CONCERNING THE TC'S DECISION NOT TO REPORT TO THE GA OR COOPERATE WITH THE C-24. VRAALSEN REPLIED IN THE NEGATIVE BUT SAID THAT HE WOULD DISCUSS THE MATTER WITH THE TC PRESIDENT. THE REPORT WAS THEN ADOPTED WITHOUT FURTHER COMMENT.
