2. ORGANIZATION:

A) THE COMMITTEE HAS THE SAME MEMBERSHIP AS LAST YEAR: THE C-24 PLENARY CONSIDERS INTER ALIA PUERTO RICO, FOREIGN ECONOMIC INTERESTS...AND MILITARY ACTIVITIES...

B) BUREAU: CHAIRMAN, SALIM SALIM (TANZANIA); VICE CHAIRMAN, ABDULAH (TRINIDAD AND TOBAGO); VRAALSEN (NORWAY), AND NEYTCHYEV (BULGARIA); RAPORTEUR, GLAYEL (SYRIA).
