(MARIANAS CONSTITUTION APPROVED)

SAIPAN, Mar. 7 (MNS) --- An overwhelming majority of the people 3 of the Northern Marianas who voted in Sunday's referendum approved 4 the draft Constitution of the Commonwealth of the Northern Marianas. 5 Resident Commissioner Erwin D. Canham reported an 6 affirmative vote of 93.3 percent. He added that approximately 7 58 percent of the voters_turned_out on Sunday out of the 6,554 8 registered voters in the Northern Marianas. 9 "The endorsement of the constitution by the people of the 10 Northern Marianas is emphatic and very gratifying. The turnout 11 of approximately 58 percent, Canham said "is good since the 12 issues of the Constitution were already voted in the covenant and 13 there were no political parties involved." 14 "I have transmitted the results to the American government 15 and will carry the signed copy of the Constitution to the U.S. 16 this week," he said. Canham and Budget Officer Ignacio Sablan 17 are leaving this week for budget hearings in Washington. 18 Canham said the number of voters opposing the Constitution came 19 20 to 258, with 19 of the votes voided.

The referendum on the Constitution was the seventh of ten 1 steps set by former Ambassador Franklin Haydn Williams leading 2 toward full-fledged Commonwealth Government. The next step 3 will be approval of the Constitution by U.S. Government probably later this year. The U.S. Congress will be given the opportunity 5 to review the constitution. 6

Following that will be the election and installation of the Commonwealth government under the new Constitution, possibly 8 during the latter part of this year. 9

(THOUSANDS ATTENDED YAP DAY CELEBRATION)

YAP, MARCH 7 (MNS) --- More than half of the population of Yap 11 proper showed up for the annual Yap Day Celebration held March 1st, 12 according to Yap Public Information Officer Willie Gorongfel. 13 Games, feasts and dances were among the main attractions of the 14 day's events. 15

The day began with a march of elders involved in the Old Age Program dressed in colorful old Yapese attire. The group marched from the old age program site to the celebration ground by the hospital where the crowd was waiting. The same group of Yapese old men and women also opened the ceremonies with their

Yap District Day was established by the Yap District 8 Legislature to honor Yapese culture and customs as well as the 9 traditional Yapese way of life. 10 (LEGISLATURE'S SOCIAL COMMITTEE HEARINGS BEGIN) 11 SAIPAN, MAR. 7 (MNS) --- Public hearings began this week on 12 Saipan for all Northern Marianas citizens who were forced to join 13 the Japanese Imperial Army during World War II, according to a 14 release from the Northern Marianas Legislature. The hearings are 15 being conducted by the Social Committee chaired by Senator Jack 16 Villanueva. 17 Those persons who served in the army were also taken to 18 Guam, the Solomon Islands, New Guinea, Indonesia and other areas 19 in the Pacific while serving in the Imperial Army, Senator Villanueva 20

1 said. The Committee is mandated by a resolution adopted during the 2 recently concluded session of the Legislature to seek, among other 3 things, compensation for all Northern Marianas citizens who were 4 drafted into the army "under threat of death to themselves or their 5 6 families..." Claims were filed under the Micronesian Claims Act of 1971 7 for compensation for service in the Japanese Imperial Army, 8 according to the resolution. "But all these claims were denied 9 on the basis that the Micronesian Claims Act of 1971 did not 10 include service in the Japanese Army," the resolution pointed out. 11 "... To allow this situation to go uncorrected would be an 12 injustice" on the part of those who served in the Japanese Army, 13 claims the resolution. The Committee is further mandated to seek 14 compensation from the Government of Japan. 15 Public hearings on Saipan will conclude on Friday (March 11). 16 The Committee will hold similar hearings on Tinian March 14 to 15; 17 and on Rota from March 17 to 19th, Senator Villanueva said. 18 .
