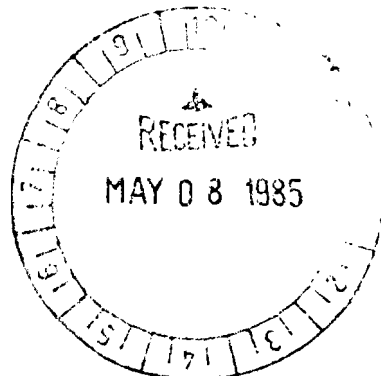

Dear Mr. Guerrero :

This is to remind you that as a candidate for delegate to the Constitutional Convention election on April 21, 1985, you are required by Article 4, Section 6341, Division 6 of the Commonwealth Code "To submit a detailed financial statement to the Board within fifty (50) days after election, showing the names and contribution of supporters contributing over \$100.00 and a detailed statement of campaign spending".

"Any candidate voilating this section shall upon conviction be fined not more than \$500.00 or imprisoned for no more than 60 days".

Remember, the deadline for submission of your financial statement is June 10, 1985. Copies of the Financial Statement form is available at the office of the Board of Elections, and members, Board of Election on Rota and Tinian.

Dear Mr. Guerrero :

According to the records of the Board of Elections:

You voted in the Constitutional Convention Election of Delegates on April 21, 1985, therefore you are eligible to vote in the general election to be held on November 3, 1985 without registering again. However, if you changed your name or residence, you need to reregister before the general election.

You failed to vote in the Constitutional Convention Election of Delegates on April 21, 1985, therefore you must reregister at the Office of the Board of Elections for you to be eligible to vote in the general election to be held on November 3, 1985.

NOTE: Registration of voters is now being conducted in the Office of the Board of Elections from 7:30 a.m. to 4:30 p.m., Monday thru Friday.

On Rota and Tinian register with the members, Board of Elections.

The last date to register for the November 3, 1985 general election is October 3, 1985.
