DELEGATE PROPOSAL NO. 153-83

A PROPOSAL

TO MINIMIZE CORRUPTION IN THE MARIANAS PUBLIC LAND TRUST BY AMENDING SECTION 6(a) and 6(f) OF ARTICLE XI OF THE NORTHERN MARIANAS CONSTITUTION.

BE IT ADOPTED BY THE SECOND CONSTITUTIONAL CONVENTION:

Section 6(a) of Article XI of the Constitution of Section 1. the Northern Mariana Islands is hereby amended to read as follows: The trust shall have three five trustees, one · · Section 2. trustee from Rota, one trustee from Tinian, and three trustees from Saipan and the islands north of it, appointed by the governor with the advice and consent of the senate. The trustees 7 from Saipan shall each represent the business community, non-8 profit organizations, and the education community (e.g. board 9 of education, board of regents, education research organization, 10 ect.). Each trustee, Rota, Tinian, and Saipan and the islands .11 north of it inclusive, shall be a person of Northern Marianas 12 descent as defined in Article XII, Section 4, a resident of the 13 Commonwealth for at least five years immediately preceding the 14 date on which the trustee takes office, a person who has not been 15 convicted of a felony and a person who is able to speak and under-16 stand Chamorro or Carolinian. The trustees shall serve for a term 17 of six years except that the term of office shall be staggered, 18 three trustees shall serve for four years and two trustees shall 19 serve for six years as determined by a draw of lots. The termined 20 office for all trustees shall commence simultaneously.
