The Committee on Local Government hereby request your approval for public hearings this weekend on Rota and Tinian on Saturday and Sunday, June 29th and 30th, respectively.



Then we will depart for Tinian on ~~Sunday~~ ^{Monday} at 11:30 a.m., and return from Tinian at 9:15 a.m., ~~Monday~~ ^{TUESDAY} July 1st.

For your information, I will bear all costs of room and board while this Committee is on Rota, and Tinian Delegate Nabors, a Member of this Committee, will shoulder all costs of room and board while on Tinian, in consideration for accepting our recommendation that all five members and the Committee Assistant will attend the hearings. The Convention will bear only the costs of all air fares and per diem of the Committee Assistant.
