Dear Mr. Chairman:

Public Law No. 4-30 authorizes the convening of the Second Constitutional Convention of the Northern Mariana Islands from June 18, 1985 to July 17, 1985.

The enabling legislation authorized the Pre-Convention Committee, which ceased to exist at the convening of the Convention, to ensure that staff support for the Convention is arranged and in proper order. Also, Section 17 of Public Law 4-30 directs the Governor, the President of the Senate and the Speaker of the House of Representatives to cooperate and make available the resources of the executive and legislative branches. Under the direction and coordination of the Pre-Convention Committee, some certain employees of the executive and legislative branches are detailed to the Convention. Some of these employees are excepted or ungraded.


In order to ensure that the Convention complete its mandate as authorized by Public Law 4-30, the Convention meets on weekends and after regular working hours. I understand that excepted and ungraded employees of the Commonwealth Government are not authorized or entitled for overtime. Therefore, pursuant to Section 11(a) of Public Law 4-32, I am requesting the Civil Service Commission to approve and certify to the Governor and the presiding officers of the Legislature the attached list of Convention staff to be allowed to work overtime when employees are required to work after regular working hours or on weekends. The period of this request is from June 18, 1985 to July 17, 1985.
