<u>PROPOSAL No.</u>	<u>SUBJECT MATTERS</u>
1. 14-85	Proposed amendment to the Constitution of the Commonwealth of the Northern Mariana Islands. Prohibition of Prostitution.
2. 62-85	Proposed amendment to amend the Constitution of the Northern Mariana Islands to provide for Chamorro-Carolinian education program
3. 78-85	Proposed amendment to amend Section 8 of Article I of the Northern Marianas Constitution relating to Trial by Jury.
4. 113-85	Proposed amendment regarding Boards and Commissions Proceedings.
5. 149-85	Proposed amendment to amend the Constitution of the Commonwealth of the Northern Mariana Islands concerning limits on wrongful death and injuries.
6. 150-85	Proposed amendment to amend Article VIII, Section 3 regarding election procedures.
7. 164-85	Proposed amendment to establish a constitutional provision for establishing the legal drinking age in the Commonwealth at age 18.
8. 174-85	Proposed amendment to amend Section 2 of Article XVIII of the Northern Marianas Constitution relating to Immunity.
9. 184-85	Proposed amendment to add a new Section to Article III to prohibit wage discrimination and require divestiture of government-owned residential housing.
10. 207-85	Proposed amendment to add a new Article to the Constitution of the Northern Mariana Islands to establish "A TAGA and AGHURUB" day once yearly for cultural revival activities by Chamorro and Carolinian of Northern Marianas decent.
11. 217-85	Proposed amendment to add a new Section 4 to Article VII of the Northern Mariana Islands Constitution relating to voting after a person's failure to vote.
12. 240-85	Proposed amendment to amend the Northern Marianas Constitution for the Legislature to provide that "incarcerated criminal must serve 50% of their jail term before they can be eligible for parole."
13. 259-85	Proposed amendment to add a new Article to the Northern Marianas Constitution regarding pornography.
14. 274-85	Proposed amendment to amend Article I of the Constitution to create a right to access government documents unless there is a compelling governmental interest in its secrecy.
