

The Committee on Executive Branch and Local Government of the Third Northern Marianas Constitutional Convention will conduct an initial Public Hearing on **Tuesday, June 27, 1995** from 9:00 a.m. to 11:30 a.m. The session will be held at the Senate Chamber. The purpose of the public hearing is to hear and receive testimony on **Proposed Amendments to Article III: Executive Branch.**

The Committee is especially interested in soliciting views regarding the constitutional offices for Carolinian Affairs, Indigenous Affairs and Women's Affairs; the processing of the Commonwealth's budget; whether the Attorney General should be an elected official; coordination between the offices of the Attorney General and Public Auditor; and the Governor's reorganization authority.

The Public Hearing will be open to the general public. Persons wishing to testify are urged to submit written testimony to Chair Felix R. Nogis, Office of the Third Constitutional Convention, Legislative Bureau, Capitol Hill, either before or after the hearing. The Committee will receive written statements until June 30, 1995. In accordance with Rule 30 of the Third Constitutional Convention's Rules of Procedure, no person shall be denied the opportunity to testify for lack of a written statement. Persons wishing to testify should inform the Chair at the outset of the session.

The Committee may schedule additional hearings on Saipan on these subjects and the question of local government. The hearings presently scheduled for Rota (June 29 and 30) and Tinian (July 7 and 8) will provide further opportunity for public input regarding Article III.


