COMMONWEALTH OF THE NORTHERN MARIANA ISLANDS

A CONSTITUTIONAL CONVENTION RESOLUTION

To unequivocally condemn and express adamant opposition to France's declared intention to resume nuclear testing in the South Pacific region.

1	WHEREAS, the proliferation of nuclear weapons, beginning with the		
2	bombings of Hiroshima and Nagasaki in 1945, followed by the military standoff of		
3	the Cold War era, and continuing with the pursuit of nuclear capability by diverse		
4	national interests, has created an unprecedented threat to the continued existence		
5	of human civilization and possibly on Earth; and		
6	WHEREAS, the pursuit of nuclear military power by nations through		
7	research, development, testing, and implementation has diverted immense natural,		
8	human and financial resources away from more productive political and social		
9	endeavors; and		
10	WHEREAS, the people of the Pacific, having been made an unwitting		
l 1	battleground for the military conflicts of World War II, were then further exploited		
12	as a testing ground for nuclear weapons by industrialized nations without		
13	consultation or consent of the affected island communities; and		
14	WHEREAS, these prior programs of nuclear testing caused untold		
15	suffering, illness and death to the indigenous people of those islands and poisoned		
16	by radioactive contamination the lands and waters which had served as their

1 livelihood since time immemorial; and 2 WHEREAS, the majority of the nations of the world have come to 3 realize that the only viable solution for the future of human civilization is the achievement of a stable world order wherein all nations can pursue 4 5 self-determination without detriment to world peace; and 6 WHEREAS, the necessary first step to a stable world order is the containment of the proliferation of nuclear weapons and eventual nuclear 7 8 disarmament; and 9 WHEREAS, to this end one hundred and seventy nations have agreed 10 to indefinitely extend the Nuclear Non Proliferation Treaty and the major 11 nuclear powers, including the United States, Britain, France and Russia are 12 scheduled to sign the Comprehensive Test Ban Treaty; and WHEREAS, in contravention of this international consensus to contain 13 14 and reduce nuclear weaponry, France has recently announced that it plans to 15 conduct a series of eight nuclear tests at Moraroa, French Polynesia between 16 September 1995 and May 1996; and 17 WHEREAS, these plans for nuclear testing represent a blatant disregard 18 and disrespect for the sentiments, health and welfare of the peoples of the region 19 and place the lands and waters of common to all Pacific peoples at risk for

1 renewed radioactive contamination; and 2 WHEREAS, the Commonwealth of the Northern Mariana Islands, by and 3 through its elected representatives in the Third Northern Marianas Constitutional Convention wish to declare solidarity with the people of French Polynesia and 4 5 join the other Pacific nations of Guam, American and Western Samoa, Papua 6 New Guinea, Nauru, Kiribati, New Zealand and Australia in opposing and 7 condemning France's plans to engage in renewed nuclear testing; now, therefore, 8 BE IT RESOLVED, by the Third Northern Marianas Constitutional 9 Convention to adamantly oppose and unequivocally condemn any attempt by 10 any nation to subject the people, islands and ocean of the Pacific to the dangers 11 and risks of nuclear testing and to express support for a permanent halt to nuclear 12 testing; and 13 BE IT RESOLVED, that the President of the Convention shall certify and 14 the Secretary of the Convention shall attest to the adoption of this resolution and 15 thereafter transmit copies to the Governor of the Commonwealth of the Northern 16 Mariana Islands, the President of the United States, the President of the United 17 States Senate, the Speaker of the United States House of Representatives, the 18 President of France, the Secretary General of the United Nations, the Governor of 19 Guam, the Governor of Hawaii, the Governor of American Samoa, and to the
