Earlier, some of his jurors explained for the first time why they acquitted him in the murders of his ex-wife and her friend. One said a cop lied, another was a racist, and the bloody gloves didn't fit-either on Simpson's hands or at his estate-so she had to acquit.

Simpson, who wasn't seen during his second day of freedom, also offered a brief comment about his first reunion with his two small children, Sydney and Justin, since he was arrested for their mother's murder.

about prosecution claims that a shadowy figure seen moving across the driveway of Simpson's house was in fact Simpson returning from an attempt to hide a bloody glove.

Simpson said testimony from limousine driver Allan Park never showed this _ only that there was a person near the front door.

"It was me_walking out of my front door, dropping my bags and going back in," he said. Simpson's defense had said that Simpson was racing around his house at about 11 p.m. packing for a tions of what was said," Simpson said.

Simpson said he went back to his cell many nights and asked of the commentators: "Were they in the same court room that we were in today? Did they hear the testimony today?"

Simpson appeared eager to cut short the interview, saying, "I gotta go."

Simpson friend Robert Kardashian, meanwhile, was reportedly behind a dlrs 1 million photo package offer to the supermarket tabloids that promised exclucomment.

In their first full day free from sequestration, some jurors spoke out.

Brenda Moran, a black computer technician from South Central Los Angeles, said a glove found behind Simpson's mansion was key to her decision to acquit the former football star in the June 12, 1994, murders of Nicole Brown Simpson and Ronald Goldman.

"Somebody planted it," Moran said, signaling she agreed with the defense contention that Simpson was framed by rogue cops.

The juror discussed the case with more than 100 reporters, who were assembled on the roof

doubt from the beginning" about the prosecution's evidence, including the blood.

"If he committed such a bloody crime, then there should have been more blood in that Bronco than this just little speck that we saw," she said.

At Simpson's estate, more than a hundred reporters gathered outside the wall that Detective Mark Fuhrman scaled the morning after the murders.

Simpson was nowhere to be seen. A rumored news conference never materialized. And his representatives have suggested if he does speak it will be in a payper-view TV special, similar to those staged for boxing matches. The event could net Simpson

Coming from our governor, of course, that's a very powerful position," Benavente said.

"I've always pushed for the people, if there's going to be a casino - if casino is going to be allowed in the Commonwealth - I would like to see the people voting for that issue and not 18 members of the House, nine members of the Senate," Benavente said.

"The members of the House of Representatives or the legislature really do not have the right to make that kind of decision. I don't think that 27 bodies have a right to make that

He also berated the Senate for passing the gaming bill.

"It seems like at the Senate 'anything is possible. It's a little different at the House. I know that there is suspicion that there's going to be a coup or that there's a coalition possibly formed to push casino in the House of Representatives. Again, I'm not aware of it. I do not believe that there's going to be a coup," Benavente explained at length.
