MEMORANDUM OF UNDERSTANDING

We, the undersigned mutually agreed to the following terms:

- 1) That the Office of Personnel on Tinian will provide one employee to the Third Constitutional Convention to assist the Convention in its work.
- 2) That the period of assignment will be from July 11 to August 5, 1995.
- That during the assigned period, for days work, the assigned employee will receive a subsistence of TWENTY FIVE DOLLARS (\$25.00) per day, to be compensated by the Third Constitutional Convention.
- 4) That during the assigned period, the employee will remain on Saipan until the end of the assignment, at which time, the employee will return to Tinian.

We affirmed the foregoing and affixed our signatures binding this Memorandum of Understanding on this 10 Handay of 1995.
