MESSAGE

I am transmitting a copy of our payment request to Finance regarding our account with you for two cars in the amount of \$2,161.91.

I checked with Treasury Division today and there is a check for Microl in the amount of \$59,000 plus. I do not know if our payment is included in this check since what Finance does is consolidate all payment requests for one vendor, especially if you have several vendors within the government.

Can you please check this out with Frank Diaz and let us know what is the status? We are not trying to avoid paying our account -- it is only a matter of getting Finance to doing it as soon as requested. I will check again, but I have a strong feeling that such request is included in the check already at Treasury Division.

Appreciate your help in this matter.
