### **MEMORANDUM**

TO: Director of Procurement and Supply

FROM: Chairman, Post Constitutional Convention Committee

**SUBJECT**: Justification - PCC96-1584-02A - United Printers, Inc.

The Ninth Northern Marianas Commonwealth Legislature established the Pre-Convention Committee, the Convention and the Post Convention Committee. The Post Convention Committee conducted the public education program to inform the general public on the proposed 19 amendments adopted by the Third Northern Mariana Islands Constitutional Convention.

Because of the short duration of the public education program, we arranged with the United Printers, Inc. to print the 19 proposed amendments in Chamorro and English languages and the ConCon Bulletins. The documents were urgently needed to provide copies to the islands of Saipan, Rota and Tinian for distribution to the general public. Also the Board of Elections requested several thousands of copies for distribution during the day of the election in order for the voters to be informed in any of the official languages of the Commonwealth which is Chamorro, Carolinian and English. It is extremely important to do because the documents were needed to be sent to the absentee voters off islands.

The regular government system takes too long for the purchase order to be processed. In view of the urgent need to have the documents printed by the **United Printers**, **Inc.**, I authorized the printing of the documents. I believe my action it is justifiable in authorizing the printing of the proposed amendments.
