**SUBJECT** : Justification - PCC96-1584-05A - Marianas CableVision

The Ninth Northern Marianas Commonwealth Legislature established the Pre-Convention Committee, the Convention and the Post Convention Committee. The Post Convention Committee conducted the public education program to inform the general public on the proposed 19 amendments adopted by the Third Northern Mariana Islands Constitutional Convention. The Post Convention Committee utilized the two television companies in efforts to conduct public education programs.

Because of the short duration of the public education program, we arranged with the **Marianas CableVision** to play the 19 proposed amendments in Chamorro, Carolinian and English, on various programs, days and times. The regular government system takes too long for the purchase order to be processed. In view of the urgent need to have the ads on the 19 proposed constitutional amendments shown on **Marianas CableVision (MCV)**, the Post Convention Committee authorized the ads with Marianas CableVision. I believe my action it is justifiable in authorizing the printing of the proposed amendments.

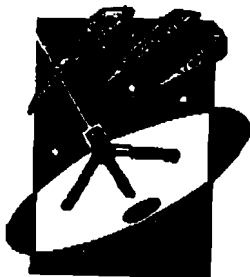

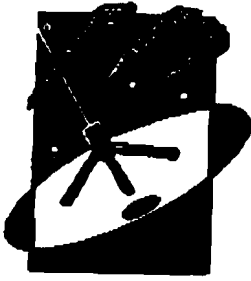
