SUBJECT : Justification - PCC96-1584-06A - Microl Corporation

The Ninth Northern Marianas Commonwealth Legislature established the Pre-Convention Committee, the Convention and the Post Convention Committee. The Post Convention Committee retained the legal counsels of Howard Willens and Deanne Siemer to assist the Committee in its work in conducting the public education program to inform the general public on the proposed 19 amendments adopted by the Third Northern Mariana Islands Constitutional Convention.

Under the provision of Contract No. C6018001 executed between Howard Willens & Deanne Siemer and myself as the Chairman of the Post Convention Committee, the husband and wife legal team (Howard & Deanne) they are entitled to miscellaneous and incidental expenses, including car rental. The Government was unable to provide the Post Convention Committee with the vehicle for its use. Additionally, the Committee rental additional vehicle for the special election on the referendum of the proposed 19 amendments.
