Now we need everyone's help in the final days to talk to friends and family, to get out the vote, and to be sure that the voters understand how important it is to support the work of the delegates.

Many politicians here in the Commonwealth expect a very low turnout, perhaps as low as 30% to 40% of the voters. If that happened, a very few "no" votes could control on each amendment. The "no" voters have a big incentive to get to the polling places and vote. Many "yes" voters may think that their vote is not important. We truly need every single vote, so I am asking you to make personal efforts next week to talk to voters and make sure we have a good turnout among our supporters.
