We've heard a lot of discussion about the Analysis to the Constitution. I'd like to explain something about the Analysis and how it is used.

The ballot on the constitutional amendments includes a description of the actual language that would go into the Constitution if the voters approve the proposed amendments. The Analysis is a 99page document that explains what the delegates intended to do when they voted for the

proposed amendments. It helps the courts and the government agencies understand how to apply the constitutional language if the voters approve.

The enabling legislation for the Constitutional Convention actually gives to the Post-Convention Committee the task of preparing the Analysis if time does not permit during the Convention. The delegates believed that it was important for the Analysis to be considered by the Convention before it adjourned. For that reason, our legal team in the Third Constitutional Convention worked overtime to get

Applicants for Firefighter Trainee must be a high school graduate or equivalent and must be able to pass the National Fire Protection Association Firefighter entry qualifications on Medical and Physical Fitness requirements.

The minimum qualification for Electronics Technician is high school graduation or equivalent, and must successfully completed related or vocational and technical certification at a U.S. accredited trade or vocational school plus three years experience as an electronics technician.

The minimum qualification for Mechanic are that applicants must be high school graduates or equivalent. and successfully completed related vocational and technical certification at a U.S. accredited trade or vocational school plus three years of experience as an automotive and heavy equipment repair and maintenance operations of which one year pertains to supervisory experience.

Application forms are available at the Security Office on the First Floor of the Arrival Building at the Salpan International Airport or at the Second Floor Administration Office. Application forms must be accompanied by an updated police clearance dating back five years. For more information, please contact Tel: 664-3500. the Analysis done in time for every delegate to be able to consider it. They did the job. and a draft of the Analysis was ready on July 29, 1995. five days before the Convention adjourned.

During the Second Constitutional Convention, we didn't have an Analysis. The staff did not prepare one.

The Analysis is drawn from the committee reports and the transcripts of the floor debates during the Convention. Any delegate was free to propose changes or new language for the Analysis, and many delegates did during the two days on which we debated and considered the Analysis.

The Post-Convention Committee considers proposed corrections to the Analysis as they come up. There are a few typographical errors and other word processing errors that perhaps should be fixed by the Post-Convention Committee. We have also expected the School Board to ask us officially to clear up the ambiguity that they find in some of the wording of the Analysis, but as yet they have not done that.

If any voter wants a copy of the Analysis or any other publication on the Con-Con amendments, like the inserts from the newspapers, they should call the Post-Convention Committee office at 235-0843 at any time.
