Apparently I was right and the legislation has been passed. Late last Friday, before the three-day weekend, the Senate passed a legislative initiative to set the cap on the budget for the Legislature at around \$7.5 million (vs. the \$9 million in the initiative that was defeated in November and \$4.5 million in the Con-Con's proposed Amendment #2). Today, late in the session after your (or someone's) news cameras left, the House passed this initiative bill as well.

The House also passed a bill postponing the Con-Con election until mid-June, allegedly for more time for public education, but in fact to provide enough time to put the legislative initiative on the ballot with the Con-Con amendments. The postponement bill went to the Senate this afternoon. Apparently the Senate will be in session tomorrow and will try to slide this by late in the day so as to avoid your last news program for the weekend. They need to get it to the Governor quickly.

We have a copy of the legislative initiative if you need it. We don't yet have a copy of the House bill postponing the Con-Con vote. You can probably get that faster than we can.
