YOUR 132109Z NOTAL. PROPOSE

- (A) AREA TO BE TRANSFERRED INCLUDE ENTIRE SAIPAN DISTRICT CONTAINING ALL MARIANAS ISLANDS EXCEPT GUAM.
- (B) ADMINISTRATION BY NAVAL ADMINISTRATOR SAIPAN DISTRICT THROUGH COMNAVMAR, CINCACFLT, CNO. CIVAD ALSO TO BE DESIGNATED CO NAVAL FACILITY SAIPAN ESTABLISHED TO PROVIDE FOR PERFORMANCE FUNCTION NOT PROPERLY ASSIGNED CIVAD ESPECIALLY IN CONNECTION WITH LAND AND FACILITIES RETAINED FOR NAVAL EX. (C) LOGISTICS TO BE PROVIDED BY CINCACFLT THROUGH NORMAL CHANNELS WITH FORCES AVAILABLE EXCEPT NAVAL AND CIVILIAN PERSONNEL REQUESTED BY SEPARATE MESSAGE.
- (D) REAL AND PERSONAL PROPERTY TO BE RETURNED UNDER AGREEMENT SIMILAR JULY 1951.
- (E) CONTINUE US POST OFFICE AND ESTABLISH NAVAL POSTOFFICE FOR 290324Z

(F) SERVICE OF ISLAND TRADING COMPANY, PACIFIC MICRONESIAN LINE, TRANSOCEAN AIRLINE, TO BE TERMINATED BEFORE DATE OF TRANSFER.

(G) SCRAP CONTRACT TO BE ADMINISTERED BY NAVY UNDER SEPARATE AGREEMENT

(H) APPROXIMATELY 370 M DOLS REQUIRED FOR FINANCING CIVAD 3RD AND 4TH QUARTER FY 1953 TO CONTINUE ADMINISTRATION AS PLANNED AND FUNDED UNDER INTERIOR DEPT. NO FUNDS AVAILABLE CINCPACFLT THIS PURPOSE. CONSIDER THESE FUNDS SHOULD BE MADE AVAILABLE BY INTER-DEPARTMENTAL TRANSFER INTERIOR TO NAVY WITH FUNDING UNDER APPROPRIATION ISLAND GOVERNMENT NAVY. REQUEST FUNDS BE MADE AVAILABLE CIVAD SAIPAN DISTRICT WITH ALLOTMENT ACCOUNTING BY NSD GUAM BEFORE 1 JAN. IN ADDITION CIVAD FUNDS REQUEST QUARTERLY M AND O ALLOTMENT 15M DOLS BE MADE AVAILABLE NAVFAC SAIPAN BY BUSHIPS. JUSTIFICATION TO BE SUBMITTED BY COMNAVMAR.

DISCUSSION WITH HICOMTERPACIS INDICATE CONCURRENCE FOREGOING EXCEPT TRANSFER FUNDS CIVAC PURPOSE NOT CONTEMPLATED. RECOMMEND DEPARTMENTAL ACTION SOONEST ARRANGE AVAILABILITY 1953 FUNDS BY 1 JAN AND PROVIDE OPERATING FUNDS FISCAL 1954. AIR MAIL LETTER FOLLOWS WITH PROPOSED TRANSFER AGREEMENT INCLUDING FISCAL DATA FURNISHED BY HICOMTERPACIS IN SUPPORT OF ESTIMATED FUNDS REQUIRED FY 1953 AND 1954.
