## NORTHERN MARIANAS ISLANDS ORDINATCE NO. 1-49:

## TO THE PEOPLE OF THE NORTHERN MARIANAS ISLANDS:


Subject: Enactment of Ordinances for the Morthern Marianas Islands.

WHEREAS, the Deputy High Commissioner of the Trust Territory of the Pacific Islands, by Interia Regulation Number 1-49, has established Civil All instruction (courts for the Trust Territory of the Pacific Islands, including carritory waters; and

WHEREAS, the High Commissioner of the Trust Territory of the Pacific Islands has appointed me to the office of Governor, Northern Marianas Islands, a sub-area of the Trust Territory of the Pacific Island, and delegated to me the authority and responsibility for enacting ordinances; and

WHEREAS, understanding of the judicial processes are deemed necessary to the preservation of law and order, pronouncements relating to the functioning of judicial processes in this sub-area are made as follows:

- I. Ordinances enacted by me have the force and effect of law upon any person residing, serving, or sojourning in the Northern Marianas Islands, except those persons having diplomatic immunity.
- II. Violators of ordinces enacted by me shall be triable as follows:
  - (a) Any person, specifically including persons serving with or employed by the armed forces of any count other than the United States of America, civilians, and natives; and specifically excluding members of the armed forces of the United States of America serving on active duty, who violates an ordinance, or part thereof, whether the violation occur within or without the designated limits of a strictly military reservation of the Northern Marianas Islands, shall be triable by Civil Administration Courts; and

- (b) Any member of the armed forces of the United States of America, serving on active duty, who violates an ordinance, or part thereof, if the violation occur without the designated limits of a strictly military reservation of the Northern Marianas Islands, shall be triable by Civil Administration Courts. If the violation occur within the designated limits of a strictly military reservation of the Northern Marianas Islands, disciplinary action may be left to the appropriate branch of the armed forces of the United States of America.
- III. The term "strictly military reservation" is defined as "the area physically occupied by organization headquarters of the armed forces of the United States of America, and bounded by generally recognized limits."
  - IV. On the Island of Saipan, only the following areas are considered as strictly military reservations:
    - (a) U.S. Naval Air Station, Tanapag;
    - (b) U.S. Army Garrison Forces, Mount Tapotchau;
    - (c) U.S. Coast Guard, Leran Station.
  - V. Wide publication of ordinances and other applicable provisions of the law will be made throughout this sub-area. Copies thereof shall be available upon request at the Office of the Provost Marshal, Tanapag, Saipan, M.I., and the Civil Administration Unit, Saipan, M.I.
