SAIPAN DISTRICT ORDER NO. 5-50:

Subj: Restricted Area

1. To insure the safety of the inhabitants of the Northern Marianas it has been determined that the area on the Northern portion of Saipan beginning at a point in Matuic at the junction of a road indicated by a road barrier and signs thence southeastward across the Island to a point at Unai Fahang as indicated by road block and signs and as is shown more specifically on Civil Administration chart #1 on file with the Clerk of Courts.
2. It is therefore ordered that all persons are forbidden to enter this area for any purpose. Those persons desiring to enter said area for any reason must obtain the written permission of the Civil Administrator. If such permission is obtained such persons are not subject to the conditions of this order.
3. Failure to conform to this order will result in a fine not to exceed one hundred dollars or 30 days in jail or both.

3. Finat-ta gi para inayan este na Orden sina humuyong gui un multa ni ti un inipos un Cien Dollars pat 30 dias gi halom calaboso pat todo i dos.
