1. By reference (a), paragraph (b), CINCPACFLT proposed that the administration of Saipan and Tinian be accomplished by a Naval Administrator Saipan District and that the Administrator also be designated as CO Naval Facility Saipan.

- 2. CINCPACFIT advised that justification for the Naval Facility Saipan was being submitted by COMMARIANAS. This has not been received to date.
- 3. Enclosure (1) advises CINCPACFLT of the proposed establishment of a Naval Administration Unit Saipan in order to expedite the allocation of funds and personnel. The justification and mission for the Naval Administration Unit Saipan are at hand in CNO and the establishment thereof can be effected prior to 1 January 1953, whereas it is not known when the Naval Facility Saipan may be established. It is necessary to accomplish some naval unit by 1 January 1953 in order to take over the administration of Saipan and Tinian as directed by Executive Order 10408.

4. It is recommended that you sign the enclosure.
