1. Draft Transfer Agreement submitted Ref A, approved by Ref B, with minor language changes Articles 1-A-1, 1B-1-d, 1-B-4 and the following:

a. 1-B-7, last sentence changed to read Quote The funds of the Saipan Copra Stabilization Fund generated from activities of the Northern Marianas Development Company will be transferred to the High Commissioner, Unquote

b. 1-C-1, deleted - subject to further negotiation.

c. 7-2, delete paragraph and insert Quote Micronesian personnel serving in Excepted Appointments under Rule VIII, Section 08.3 of the Civil Service Regulations, are not eligible for transfer. The Micronesian personnel who are to be reemployed by the Government of the Trust Territory will be separated to accept appointment by the Government of the Trust Territory under its existing Micronesian employment procedures. In the reemployment of Micronesian personnel consideration will be given wherever possible to performance and seniority status. Those Micronesian employees who are not to be reemployed by the Government of the Trust Territory will be separated effective 30 June 1962 by reduction in force Unquote
