Migration and Immigration Regulation No. 1, for Saipan District of the Trust Territory of the Pacific Islands, promulgation of.

This regulation is hereby promulgated to become effective 30 days after date and to read as follows:

IMMIGRATION AND IMMIGRATION REGULATION NO. 1

Pursuant to the provisions of Section 642 of the Code of the Trust Territory of the Pacific Islands and the authority vested in me by Commander in Chief U. S. Pacific Fleet, persons not themselves citizens of the Trust Territory nor legal residents thereof shall not enter the Saipan District of the Trust Territory, defined as that part of the Trust Territory and the territorial waters thereof, which lie north of 14 degrees 45 minutes North latitude, and west of 150 degrees east longitude, except in accordance with and subject to the provisions set out below:

1. Permits to enter the Saipan District of the Trust Territory may be issued in the discretion of Commander Naval Forces Marianas or his duly authorized representatives upon submission of the following documents and information:

a. Written application in a form prescribed by Commander Naval Forces Marianas.

b. Statement by the District Administrator of the Saipan District that housing and subsistence are available to the applicant.

2. Permits will be valid for a period of time deemed reasonable by the issuing official, subject however to revocation by Commander Naval Forces Marianas in his discretion at any time.

3. In addition to such permit, visitors will be required to have in their possession at the time of entering the Trust Territory or any District thereof the following:

a. Valid passport or its equivalent, and in the case of non-United States citizens a valid re-entry permit or equivalent to the country of their domicile or a visa authorizing further travel.

b. Evidence of inoculation within three (3) years against smallpox; inoculation or re inoculation within one (1) year against cholera and typhoid, and a certificate of freedom from contagious disease, the latter to be signed by a duly licensed physician or government medical officer.

3. All visitors to the Trust Territory of the Marianas shall have security clearances issued by the cognizant United States Agency to enter the Trust Territory or such portion thereof as the visitor may desire to enter.

4. Employees of the Trust Territory Government and those employed by the Government of the United States including all Members of its Armed Services are hereby excused from obtaining visitors permits when entering the Saipan District on official business. They shall, however, be subject to and comply with all conditions set forth in paragraph (3) above.

5. Nothing in the foregoing shall be deemed to prevent Commander Naval Forces Marianas from issuing Entry Permits without reference to this regulation when in his judgment the circumstances so warrant.
