Subj: Informal Investigation into the circumstances attending the alleged injuries of one Luis D. MISA, Filipino employee of Brown-Pacific-Maxon; report of

1. Readdressed and forwarded for information.
2. On receipt of enclosure (17), an informal investigation was ordered to inquire into the circumstances attending the alleged injuries of Luis D. MISA. The following comments are submitted on basic correspondence, the result of this investigation:
 - a. Sala. It is noted that the District Attorney, Saipan District did order an investigation prior to the return of MISA to Guam.
 - b. Sala. Further inquiry reveals that the Trust Territory Code contains only a few general regulations on Immigration and that enclosure (18) is the only additional Immigration instruction in effect at present. General written instructions for the guidance of the District Immigration Officer on the handling of aliens, deportation proceedings, deportation, detention, etc. have not been issued.
 - c. Zala. Commander Naval Forces Marianas concurs and will issue instructions to the Naval Administrator on the premises.
 - d. Zala. Action will be taken as denoted in (c) above.
 - e. Zala. Commander Naval Forces Marianas concurs and will propose such Immigration regulations as are appropriate to the Commander in Chief U. S. Pacific Fleet for approval.
 - f. Zala. Action will be taken as denoted in (c) above.
 - g. Zala. Commander Naval Forces Marianas will undertake the study, and, if legal and deemed necessary, will propose such legislation to the Commander in Chief U. S. Pacific Fleet for approval.
