An Ad-Hoc Subcommittee representing the four secretaries mentioned above was constituted. My representative on the Subcommittee was Mr. Fred Searls, Jr. Mr. Searls, as Chairman of the Subcommittee, has submitted a report to me dated February 23, 1946, in the following terms:

"At a meeting of the Ad-Hoc Subcommittee of the above Committee held in the Department of State on January 30, 1946 a resolution was passed to submit to your Committee a proposal of the Department of the Interior, received in draft form at the Subcommittee meeting and subsequently withdrawn by the Interior member for correction, together with the Subcommittee's recommendation that no action be taken on the proposal by your Committee until such time as the status and title of the Pacific Islands concerned should be determined. The Interior Department representative voted nay on this resolution.
