"It was with a feeling of admiration and respect that I listened to the opening statement of the High Commissioner and in particular to his subsequent replies to questions put to him by members of the Council. Mr. Midkiff has been in office, I understand, for only a few short months, but already he has clearly acquired an almost encyclopaedic knowledge of the affairs of the Trust Territory."

"We are encouraged by the fact that the High Commissioner, whose competence and human warmth we have highly appreciated, was kind enough to take some of our observations into account."

MR. DE MARCHENA (for the Dominican Republic):

"My delegation wishes to associate itself with those representatives who have spoken of the great work done by the High Commissioner. From the first contact of the Visiting Mission with the High Commissioner, a few days after his appointment, we were convinced that we had in him a man not only of great capacity, but of gifts which would be most helpful in his work. We feel that a most happy choice was made in his appointment."
