CONGRESS OF MICRONESIA ENDS FIRST WEEK

SAIPAN, M.I. (July 16)...The Congress of Micronesia ended its historic first week today in the provisional capital of Micronesia, Saipan, Mariana Islands. Its members have organized, elected officers and committees, and introduced numerous bills and resolutions.

The House of Delegates of the Congress was called to order at 10:00 a.m. July 12, by High Commissioner M. W. Goding. John O. Ngiraked of Palau was elected Provisional President. The actual organization of the House of Delegates did not take place until the afternoon of July 14. The delay was caused by a committee hearing on the credentials of one of its delegate-elects from the Marianas, Jose R. Cruz. After Mr. Cruz's credentials were accepted and he was sworn in, the House recessed to a closed caucus to elect its officers. The caucus continued until the afternoon of July 14 when the following officers were elected: Tosiwo Nakayama, Truk, President; and Bailey Olter, Ponape, Vice President.

Among the 21 resolutions introduced in the House were those calling for the establishment of a junior college within the Trust Territory and for the Trust Territory government to provide a qualified legal officer for each district.

Among the 17 bills introduced, one called for control of temporary foreigh labor brought into the Territory. Another would require Micronesian approval prior to any foreign enterprise receiving a charter from the High Commissioner to conduct business in the Trust Territory.

The General Assembly of the Congress was called to order by Richard F. Taitano, Deputy High Commissioner of the Trust Territory at 10:00 a.m., July 12. The Oath of Office was administered by Mariana Islands District Court Presiding Judge Ignacio Benavente. The General Assembly officers are: Dwight Heine, Marshalls, Speaker; Petrus Mailo, Truk, Vice Speaker; and Bethwel Henry, Ponape, Legislative Secretary.

Among the first week's 23 resolutions introduced in the General Assembly were those which called for an accelerated hospital program and review of the Trust Territory budget.

The 17 bills introduced covered a wide variety of subjects. One would require Trust Territory government employees to declare names of companies in which they hold financial interest. Another would require review of preliminary district budgets by district legislatures prior to their submission to the High Commissioner by the district administration.

The first joint session of the new Congress, which met at 2:00 p.m. Monday, July 12 in the Theartre Building of the Trust Territory Headquarters.

attracted several hundred guests and spectators. High Commissioner of the Trust Territory, M. W. Goding, delivered his "State of the Territory" message at this joint session.

Guest speakers were John A. Carver, Jr., Under Secretary of the U.S. Department of the Interior, under whose administrative jurisdiction the Trust Territory operates; and two members of the Committee on Territorial and Insular Affairs, U.S. House of Representatives - Rep. Rogers C. B. Morton (R., Md.) and Rep. N. Neiman Craley (D., Pa.).

A two-week pre-Congress session was conducted by the Institute of Technical Interchange, East-West Center, University of Hawaii, represented by Dr. Y. Baron Goto. This field training was to help the new legislators acquaint themselves with legislative procedures and to give advice on techniques of holding a Congress. Working with the Congressmen were: Dr. Norman Meller, Professor of Political Science, University of Hawaii; Mr. Tom Dinell, Director/Résearcher, Legislative Reference Bureau, University of Hawaii; and Thomas P. Gill, former member of the U.S. House of Representatives, now Director of the Hawaii State Office of Economic Opportunity.

The Administration of the Trust Territory is readying several bills for presentation to the Congress. It is expected that High Commissioner M. W. Goding will present the Trust Territory fiscal year 1966 budget to a joint session of the Congress next week.
