SAIPAN, M. I. (NOV 23). . .Ten new staff members have arrived recently to fill positions on the Staff of the High Commissioner at Headquarters in Saipan.

The new Director of Dental Services, Molly O. George, was born in Woolwich, Kent, England. She received her doctor of dentistry from the University of Minnesota and a master's degree in dentistry from Harvard University in 1957.

She has had many years of experience as a public health dentist in Minnesota; Guam; Richmond, Virginia; and in Puerto Rico. Prior to coming to the Trust Territory she was Chief of the Dental Sciences Branch of the Smithsonian Institution, Washington, D. C.

Three new staff members have joined the Budget and Finance Office and a fourth, Lorin P. Anderson, is scheduled to arrive.
