

A RESOLUTION

Commending High Commissioner Edward E. Johnston and his administration for their efforts to decentralize many of the activities of the Trust Territory Government, to increase the involvement of Micronesians in the Legislative Branch of the Government in determining the programs and policies of the Government at both the district and territorial levels, and to increase the number of Micronesians in key positions in the Executive Branch of the Government who are responsible for implementing the programs and policies that are established by the Legislative Branch of the Government.

1 WHEREAS, Micronesia has been under the Administration of the United
2 States for over twenty-five years; and

3 WHEREAS, despite the obligation it undertook in the Trusteeship
4 Agreement to promote the development of the inhabitants of the Trust
5 Territory toward self-government or independence, the Administering
6 Authority has been extremely reluctant over the past years to give
7 Micronesians a true voice in the Government in Micronesia; and

8 WHEREAS, since High Commissioner Edward E. Johnston took office, the
9 new Administration, under the direction and guidance of Secretary of
10 Interior Walter J. Hickel, has taken vigorous strides to accelerate the
11 rate of political development in Micronesia; and

12 WHEREAS, the new Administration has managed to achieve an unprecedented
13 level of funding for the Trust Territory, enabling it to undertake a highly
14 accelerated capital improvement program, and at the same time has taken
15 initial steps to involve not only the Congress of Micronesia, but also
16 the District Legislatures, in the Trust Territory Government budgetary
17 process; and

18 WHEREAS, for the first time in the history of the District Administra-
19 tion in Palau, Palauan citizens have been appointed by High Commissioner
