SUBJECT: Proposed White House Sponsorship of
 Secretary Morton's Visit to the Trust
 Territories of the Pacific Islands
 Next Month

At Tab A is a memorandum from you to the President requesting that he approve a proposed trip by Secretary of the Interior Morton to the Trust Territories of the Pacific Islands (TTPI) next month, and that the Department of Defense be instructed to provide an aircraft for the trip at no expense to Interior. The request originated with Ambassador Haydn Williams, the President's Personal Representative for Micronesian Status Negotiations, and Ambassador Arthur W. Hummel discussed it with General Haig earlier this week. (General Haig agreed in principle with the request.) The purpose of Secretary Morton's visit is to capitalize on negotiating progress which Ambassador Williams achieved with Micronesian representatives earlier this month. Under Secretary of State Irwin has indicated his agreement with the need for Secretary Morton's trip.

Recommendation:

That you sign the memorandum to the President at Tab A.
