SUBJECT:

Proposed Call on You by the President's
Personal Representative for Micronesian
Status Negotiations

Ambassador F. Haydn Williams has asked to call on you sometime during the week of April 23-27 to discuss our basic position on the Marianas status negotiations, which will get underway next month. As you will recall, you were unable to see Ambassador Williams this past week to equip him with preliminary guidance for his initial talks with the Marianas representative who was visiting Washington. By April 23, we will have received the Under Secretaries Committee's policy study on this question and will have it ready for your and the President's consideration.

As you know, our basic immediate objective in the Marianas negotiations is to conclude the talks quickly on generous terms for the beneficial effect that such a settlement should have on our negotiations with the other five districts -- which do not want the closer association with us that the Marianas do.

In addition to giving Ambassador Williams policy guidance, your meeting with him will give him the added authority he needs as the President's representative in these talks.

Recommendation:

That you authorize me to arrange with Dick Campbell for a convenient time for Ambassador Williams to call on you.
