Ambassador F. Haydn Williams, the President's Personal Representative for Micronesian Status Negotiations, has informed us that Mr. James M. Wilson, Jr., his deputy, who is a Foreign Service Officer, Class 1, is being reassigned to Deputy Secretary Ingersoll's immediate staff. In fact, Mr. Wilson already is splitting his days between the two jobs, and expects shortly to begin working for Mr. Ingersoll full time. This will leave Ambassador Williams critically short-handed at a time when he has begun to move ahead full steam with preparations for the June plebiscite on the Covenant we have just signed with the Northern Marianas. Ambassador Williams is urgently interviewing replacements for Mr. Wilson.

I recommend that you call Larry Eagleburger asking his support for Ambassador Williams' efforts to find a replacement for Mr. Wilson, and for Deputy Secretary Ingersoll's agreement that Mr. Wilson should continue to help Ambassador Williams part-time until his replacement has joined Ambassador Williams' staff.
