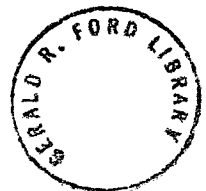
I shall be happy to discuss this or related matters further with you, as you may wish.


