With the announcement of Ambassador Haydn Williams' resignation as your Personal Representative for Micronesian Status Negotiations, we minority members of the Subcommittee on Territorial and Insular Affairs, U. S. House of Representatives, wish to commend him for distinguished national service. Over the years, our contact with the Ambassador has been frequent and cordial. His patience and explicitness in clarifying the ramifications involved in creating America's newest territory, the Northern Mariana Islands, were instrumental in achieving unanimous House approval of the Commonwealth Covenant.
