1. PRESIDENTIAL STATEMENT AS CHANGED FOLLOWS IN PARA 2.
 ARMACOST WILL BE UNABLE TO ATTEND CONFERENCE.

2. BEGIN TEXT: ON THE OCCASION OF THIS IMPORTANT CONFER-
 ENCE, I WANT TO WELCOME OUR MICRONESIAN FRIENDS TO HONOLULU.
 MICRONESIA AND THE UNITED STATES HAVE HAD A LONG AND
 MUTUALLY BENEFICIAL RELATIONSHIP. THE UNITED STATES
 INTENDS TO PRESERVE A CLOSE ASSOCIATION WITH THE PEOPLE
 OF MICRONESIA. OUR GOAL IS TO DEFINE TERMS FOR OUR FUTURE

ASSOCIATION THAT WILL PROTECT OUR RESPECTIVE INTERESTS,
 NURTURE OUR FRIENDSHIP, EXPRESS THE WILL OF THE PEOPLE OF
 MICRONESIA, AND PERMIT EARLY TERMINATION OF THE TRUSTESHIP
 STATUS ON A MUTUALLY AGREEABLE BASIS.

3. IT IS MY HOPE THAT THROUGH THIS WEEK'S DELIBERATIONS WE
 MAY PUT PAST PROBLEMS BEHIND US. I CAN ASSURE YOU THAT
 ACTIONS BY U.S. OFFICIALS SUCH AS THOSE DESCRIBED IN THE
 INOUYE COMMITTEE REPORT WILL NOT RECUR UNDER MY ADMINISTRA-
 TION. FOLLOWING THESE CONSULTATIONS WE MUST MOVE ON TO
 RESUME FORMAL NEGOTIATIONS CONCERNING THE FUTURE RELATION-
 SHIP BETWEEN US. MY ADMINISTRATION WILL MAKE EVERY EFFORT
 TO ACHIEVE TERMINATION OF THE TRUSTESHIP BY 1981.
