Policy Review of Micronesia Status Negotiations SUBJECT:

Pursuant to Deputy Secretary Clark's designation of me as Chairman of the Interagency Group on Micronesia in replacement of the former Counselor of the Department, I am convening an initial meeting of the Interagency Group on March 23 at 3:00 p.m. in the Department of State, room 7227. Please confirm the names of your representatives to Allen R. Overmyer of my staff at 632-0004.

Pursuant to a 1969 Presidential decision to terminate the UN Trusteeship, the U.S. has been engaged in negotiations which culminated with the initialing of a Compact, ad referendum, which sets forth the political, strategic, and economic relationship between the U.S. and the three Micronesian governments. As soon as possible, we need to determine the new Administration's position by undertaking a major policy review.

## **AGENDA**

I believe we should move immediately to: a) review U.S. interests in Micronesia; b) identify principal issues facing us there; c) review the documents thus far negotiated and the extent to which they do or do not meet U.s. interests; and d) consider possible alternatives.
