Thank you for your April 22 letter to the President regarding the Legal Services Corporation.

TAMEDA

As you know, the Administation has undertaken an intensive analysis of federally-funded programs for the President's Economic Recovery Program. As part of this effort, the President has proposed a social services block grant which will replace a number of separate categorical programs, including the Legal Services Corporation. The block grant will provide broad discretion to choose which services are most effective and should be financed. We believe this will strengthen local self-government for the Federated States of Micronesia.

There will be no upper limit on the share of funds which could be devoted to legal services or any other activity which best meet local needs. Legal services grantees now receiving funds through the Corporation, such as Micronesia Legal Services, may merit continued or added funding.

Thanks again for sharing your views with the President. I hope you will continue to share your thoughts on the Administration's policies with us in the months and years ahead.
