Subject: Letter from President Amata Kabua

The attached correspondence which was sent to us for appropriate action contains a letter from President Kabua of the Republic of the Marshall Islands to President Reagan congratulating him on his re-election and urging prompt ratification of the Compact of Free Association and a letter of acknowledgement from the White House.

The Compact of Free Association along with a draft transmittal letter from President Reagan urging Congress to approve the Compact, was forwarded to the Office for Management and Budget for review on January 12. When the Compact is re-transmitted to Congress, the Office for Micronesian Status Negotiations will inform President Kabua and a copy of the letter will be forwarded to your office.
